COMMENTS ON THE JULY 15, 2018 ASSIGNED COMMISSIONER RULING BY THE CORPORATION FOR EDUCATION NETWORK INITIATIVES IN CALIFORNIA (CENIC)

I. Introduction

The Corporation for Education Network Initiatives in California ("CENIC") respectfully submits these comments on the July 15, 2018 Assigned Commissioner Ruling ("ACR") setting workshops and seeking comments on eligibility for and prioritization of broadband infrastructure funds from the California Advanced Services Fund ("CASF") in the above referenced proceeding. CENIC is appreciative of the opportunity to participate in the July 25, 2018 workshop, and for the granting of party status in order to provide these comments for consideration in the record.

II. Discussion

A. Eligibility

In the ACR, the California Public Utilities Commission ("CPUC") notes that served census blocks may not serve all households within a census block, and asks if a subscription rate of less than 51% of all households should qualify a census block to be eligible for the CASF.

CENIC would suggest another factor that the CPUC considers is the connectivity status of an anchor institution within the census block. For example, the Del Norte Center at the College of the Redwoods does not have broadband connectivity; however, this site is located within a census block that is considered served. While the bandwidth needs of anchor institutions are far greater (and require symmetrical download and upload speeds) than the bandwidth standard set by the California Legislature and CPUC for households, the lack of connectivity to an anchor could be indicative of the lack of available broadband infrastructure or capacity in the surrounding area.

We would also encourage the CPUC to allow census blocks, where an anchor institution is located without households (identified as a grey census block), but is located adjacent to an unserved census block, to be considered as an eligible area for a grant. These census blocks should be part of a larger CASF project that encompasses unserved census blocks, and in keeping with the spirit of this program, should not be funded independently. While increasing connectivity at an anchor does not directly impact the goal of achieving 98% availability, it does tend to make a project more sustainable for an applicant to have long-term customers in the area as high-speed broadband will only become more vital to anchor institutions each passing year.

B. Prioritizing Projects and Areas to Serve

As mentioned in our request for party status, CENIC's members consist of public libraries, K-12 districts and schools, community colleges, California State Universities, Universities of California, private universities and more. As such, CENIC would suggest that the CPUC consider prioritizing unserved census blocks where an anchor institution is located. By prioritizing census blocks with anchor institutions, our vital public-serving institutions will

benefit from improved connectivity and assist with exposing more individuals to the benefit of broadband access, which theoretically will help with the adoption issue in the long run.

CENIC is providing a list of sites that we have compiled since the public workshop for consideration in determining priority areas (see Attachments A and B). We do acknowledge that some of these sites have connectivity; however, they are located in a census block that are CAF II locations or are served, but have insufficient connectivity to meet the anchor institution's needs. Additionally, we caution that this is not an exhaustive list of all possible sites. For example, with libraries, who are CENIC's newest segment, we do not have data on every library branch (as only those who have pursued connectivity through CENIC are known to us), and for some of these sites, we have either: received bids from telecommunications providers, but the costs were too expensive; were wireless only, but still too expensive; or received no bid at all. We will continue to work with our members to continue to update and refine the list provided, and share an updated list with the CPUC in the future. The lists of sites in Attachment B also indicates those sites which would like to connect to high-speed broadband or connect at higher speeds, and which we hope informs providers of potential locations to serve or target to improve their infrastructure.

In AB 1665, the statute allows the CPUC to consider "fund[ing] all or a portion of the project. The commission shall determine, on a case-by-case basis, the level of funding to be provided for a project and shall consider factors that include, but are not limited to, the location and accessibility of the area, the existence of communication facilities that may be upgraded to deploy broadband, and whether the project makes a significant contribution to achievement of the program goal." CENIC would suggest that a factor the CPUC could consider is if the project area includes (an) anchor institution(s). The CPUC could condition a full funding award on the

requirement that the provider must provide a free drop to the anchor. A similar approach was taken in AB 2987 – the Digital Infrastructure and Video Competition Act¹ as well as with the American Recovery and Reinvestment Act, Broadband Technology Opportunities Project². For CAF recipients, they are required to bid in response to Form 470 submissions made by schools and libraries in the areas where they receive CAF funding — and to offer service at pre-discount rates that are "reasonably comparable to rates charged to schools and libraries in urban areas for similar services." The Commission could take a similar approach with CASF projects. CENIC would recommend that any anchor institution included in a project must be connected back to the Z location as determined by CENIC, which we would do in consultation with the segment. This would ensure that the anchor's network configuration and engineering is taken into account.

C. Middle-Mile Infrastructure

CENIC would suggest that middle-mile infrastructure that is tied to connecting an anchor institution should be viewed as indispensable and thus, eligible to be funded. Typically, anchor institutions need more robust service, and it may be necessary for a provider to upgrade their networks in order to deliver the service needed. Purchasing or leasing middle-mile for contract terms beyond five years tends to be more economical in the long run. By supporting the build out of middle mile for commercial carriers, it ultimately serves communities that have little or no access.

D. Line Extension Items

For the line extension program, the CPUC could additionally consider households where there is at least one child enrolled in K-12 educational system as this could help address the

"homework gap" issue for these students as well as adult learners who are enrolled in the

California Community Colleges, Online Community College. With the advent of online testing

and increasing usage of digital content, access to broadband is important for students in order to

complete their homework, and a cellphone is not a sufficient substitute. The Governor's new

Online Community College is aimed at the nearly 2.5 million Californians between the ages of

25 and 34 who are in the workforce, but lack a postsecondary degree or credential necessary to

increase their earning potential. It is anticipated that students will begin enrolling in the last

quarter of 2019, and access to broadband will be necessary for their success in the program.

III. Conclusion

CENIC is grateful to have the opportunity to provide these comments and looks forward

to providing additional information on other sites as we continue to work on our list of priority

areas. CENIC is supportive of the CASF program, and encourages the inclusion of anchor

institutions and the public benefit that they provide to Californians.


