**LATE-FILED THREE DAY NOTICE OF GRANT OF REQUEST FOR EX PARTE  
MEETING OF COMCAST CORPORATION**

Pursuant to Rule 8.3(c)(2) of the California Public Utilities Commission (“Commission”) Rules of Practice and Procedure, Comcast Corporation (“Comcast”) submits this notice that Commissioner Carla Peterman granted the request of Comcast for an individual *ex parte* meeting to discuss the proposed decision in the above-referenced proceeding on Wednesday, March 11, 2015 from 3 to 4 pm. This meeting was originally scheduled for 30 minutes, and was later extended to a one-hour time slot the day before the meeting occurred.

Because the “initial individual meeting” with Commissioner Peterman has already been noticed by other parties, it is unclear whether a three-day notice is required in this instance. However, Comcast is filing this notice out of an abundance of caution because the duration of its meeting with Commissioner Peterman may impact other parties’ “equal time” under Rule 8.3(c)(2) of the Commission’s Rules of Practice and Procedure. Note that this notice could not

have been filed three days in advance because the additional time that arguably triggered the need for such notice was not granted until the day before the meeting.
