**Subject:** A.19-01-003 Comcast Phone Request for Leave to File Reply

Administrative Law Judge Zhang,

Comcast Phone of California, LLC requests leave to file a reply to the *Comments of Ponderosa Telephone Co. to Comcast Phone of California, LLC's Response to Administrative Law Judge's Ruling Requesting Information*, which Ponderosa filed on Monday. Comcast Phone believes a reply is important to address several inaccuracies in Ponderosa's filing. While the California Public Utilities Commission Rules of Practice and Procedure (CPUC Rules) provide no guidance on how to request leave to file a reply in this context, a close analogue would be motion practice, governed by CPUC Rules, Article 11, in which movant may file a reply "with permission from the Administrative Law Judge." CPUC Rule 11.1(f). In practice, such requests for permission are typically made by an email, like this one.

In order to expedite your review, Comcast Phone will file its reply on or before Wednesday, November 6.
