Subject: A.20-05-010 E-Mail Ruling Regarding Applicants' Prepared Testimony

This e-mail ruling provides guidance regarding Applicants' submission of prepared testimony. In the meet and confer report submitted on July 20, 2020, the parties proposed that the Scoping Memo and Ruling (Scoping Memo) be issued by July 31, 2020 and that Applicants submit their prepared testimony by August 4, 2020. That proposed deadline for Applicants' testimony may not provide sufficient time for Applicants to submit testimony that responds to all issues in scope to be included in the Scoping Memo. Applicants are directed to submit their initial prepared testimony by August 4, 2020. If Applicants believe that the initial prepared testimony needs to be supplemented, Applicants may file a motion to do so, with that motion identifying the issues for which supplemental testimony is needed, explaining why testimony on those issues could not have been submitted by the August 4, 2020 deadline, and specifying the proposed deadline for submitting supplemental prepared testimony.
