Ms. Baldwin,

Community Union believes the crux of the investigation and harassment initiated by Robert Wullenjohn of the Communications Division is due to racism. No other agency funded in 2012 by CASF was minority-led, and no other agency was audited except the sole minority-led organization California's One Million NIU. Given the tremendous success of our project in promoting broadband adoption, how Community Union became an adversary and not a partner in this CASF relationship is a mystery, and believe it was racially motivated. Our consortia promoted in Spanish, Chinese and Korean languages, and believe Mr. Wullenjohn never took the time to understand(translate) those TV and Newspaper promotions and therefore could not interpret the success we enjoyed.

We have also researched and found Mr. Wullenjohn has previously been accused by staff at CPUC, subordinate to him, to have been accused of racism. We believe it is pertinent to ascertain Mr. Wullenjohn's personnel file relative to the number of claims and complaints filed against Mr. Wullenjohn for racist remarks or racially motivated actions against his subordinates over the last 20 years, as we suspect there is a pattern. We ask that you provide this information as part of the Discovery process.
